



Historical Income & Expenses







Paycheck Protection Program (PPP Loan)

In 2021, CCHOA applied for a PPP loan and qualified for \$399,000. This loan is forgivable and will help build the Reserve Fund for upcoming infrastructure work.

Collections Status

How the HOA keeps delinquency to 2.8% each year

- On-line payment option through the website
- Reminder/delinquency notices sent out
- Payment plans offered on all past due amounts
- Liens filed on past due accounts.
- Accounts turned over to the attorney if there is no contact from the owner.

Special Project of the CCHOA

- Long Term Landscape & Irrigation Planning and how to address the aging infrastructure/construction damage throughout the commons areas.
- The Monument construction was completed at Slaughter Lane and Escarpment Blvd. The landscaping was completed in 2021
- The Addition of a shade cover at the Avana park.

The Austin Mobility Corridor Project

- A multi-use path for both sides of Slaughter Lane is one of the bonds projects. This path will render large portions of the Slaughter Lane irrigation system unusable. The CCHOA has been working closely with the Mobility Corridor Design Team and transportation on this issue.
- A large part of this project will include additional intersection improvements at Escarpment/Slaughter. Most of the median in front of Bank of America/Subway will be removed and only approximately 3 trees will remain. This portion of the project has been delayed due to permitting and watershed issues. It should be done at the end of the project.



The Austin Mobility Corridor Project

- The Corridor Project team did start the proposed sidewalk project between Barstow Ave and Gorzycki Middle School. Construction did stop on this project due to permitting issues. Construction is planned to resume during the summer of 2022.
- At Vinemont and Slaughter, the City has installed a pedestrian crosswalk system (Pedestrian Hybrid Beacon) over to the Circle C Park. This will allow for folks to safely cross Slaughter Lane at this intersection.
- The CCHOA has attended three years of meetings on this project and have achieved the following:
- The west side of Escarpment, tree and landscape light area will be left alone if at all possible



The Austin Mobility Corridor Project

- The City must provide tree mitigation (replacement) for any hardwood tree over 8". All replacement trees will be planted in Circle C if at all possible.
- The City has agreed to put the multi-use path going through
 Circle C at the end of the project to give us more time to work on
 how to move the irrigation.
- The CCHOA is asking the City to delay the part of the path between Beckett and Vinemont to another bond package to buy more time for irrigation relocation.
