November 7, 2012

At approximately 9:35am, an elderly woman (of Asian descent) entered the Circle C Café. Chef Jaime tried to speak with her, but she did not speak English. Before he could stop her, she ran for the access door into the Swim Center. She placed her arms behind her back and ran for the pool. Jaime was able to catch up to her and stop her before she dove into the water. He alerted the lifeguard on stand, Sarah Humphrey, of the situation.

The woman was crying and yelling, but not speaking English. Lifeguard Young To, and also the Senior Staff on duty, responded to the situation. At that point, Alex Kong, a resident, came out of the restroom. He was able to translate what the woman was saying. She was yelling that she was trying to kill herself in the pool to prove that she was right and her daughter was wrong. Soon after this, the woman's daughter and son-in-law arrived at the scene. She informed Jaime that she was a nurse and that her mother had Alzheimer's disease. The woman had asked her daughter to take her to the pool so she could kill herself. The woman then ran out of the house.

The woman's daughter did not want to give our staff any identifying information regarding her or her mother. The woman left the Swim Center by escort from her daughter and son-in-law.
