Previously, as Vice President of Constituent Relations at Texas Exes, the alumni association for The University of Texas at Austin, Daniel focused on educating, organizing and connecting the vast network of Longhorns to the political process, with a goal of advancing higher education on both the state and federal levels. He also managed donor relations and stewardship for the association, ensuring generous alumni and friends were presented with opportunities to support the organization through giving societies, scholarships, etc. and kept them current on the great work going on at Texas Exes and the university.

Prior to his work with Texas Exes, Daniel was the Director of Governmental Relations at Texans for Economic Development. This organization was established to increase the state's economic growth and revitalize the eroding Texas horse and greyhound racing industry. We love the community! We've found our neighbors to be friendly and courteous, and there are always people out and about in our community at the playgrounds, running, walking and biking. We also love the location relative to downtown Austin, as well as other businesses that meet the needs of our family such as shops and restaurants. Additionally, the schools are great here, Circle C Ranch is well-maintained and has many amenities, which makes us feel strongly that it's a wonderful community for our kids to grow up in.

3. Have you participated in CCHOA related activities in the past or been a member of other volunteer-driven organizations? If so, please describe such participation or membership.

I've not participated in CCHOA activities previously but have always been a part of organizations driving our community forward. For over 10 years I have been involved in the Young Men's Business League, and sat on the board of directors for that organization for 7 years, including 3 years on the Executive Committee, one as President of the board of directors. YMBL is strongly driven by volunteers with over 250 members of the League, and also managed a full-time staff that conducts the operation of a residential summer camp for 1,000 kids annually with an annual budget of over \$1.3m.

Additionally, I have worked for several large and small non-profits and membership-based organizations as a member of the leadership team. I also run a grassroots advocacy firm, so have significant knowledge of non-profit and association budgeting, membership participation and engagement of volunteers.

4. Do you have any special expertise or knowledge that could be useful to the CCHOA?

I have experience in budgeting, volunteer engagement, non-profit and association management and marketing. Additionally, I've been heavily involved in politics on the state and local level throughout my career and would be able to bring that expertise and those connections to bear as a member of the CCHOA Board.

5. How many hours do you have to devote to CCHOA related activities?

When I have committed myself to an initiative, I'm all-in. I spend whatever time is necessary to fulfill my duties, and I do expect to have the capacity to serve in a board role on the CCHOA. As president of YMBL I was giving 20-30 hours a week to that role, while raising my kids and maintaining my career.
